1. Welcome and Roll Call

Cheryl Giggetts, Chair of Operations and Performance Committee, welcomed everyone and opened the meeting at 10:00 a.m.

2. Review meeting agenda and format

Ben Bowman explained the agenda schedule and the intended purpose of the closed session to discuss the procurement process regarding the Youth program.
